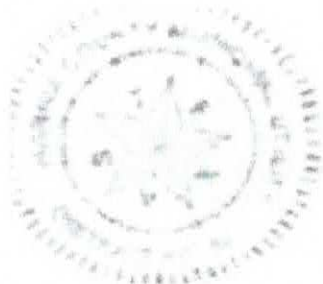
NOTICE
